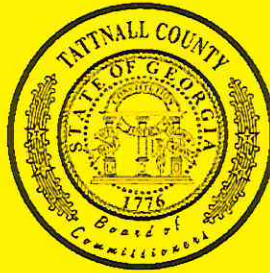

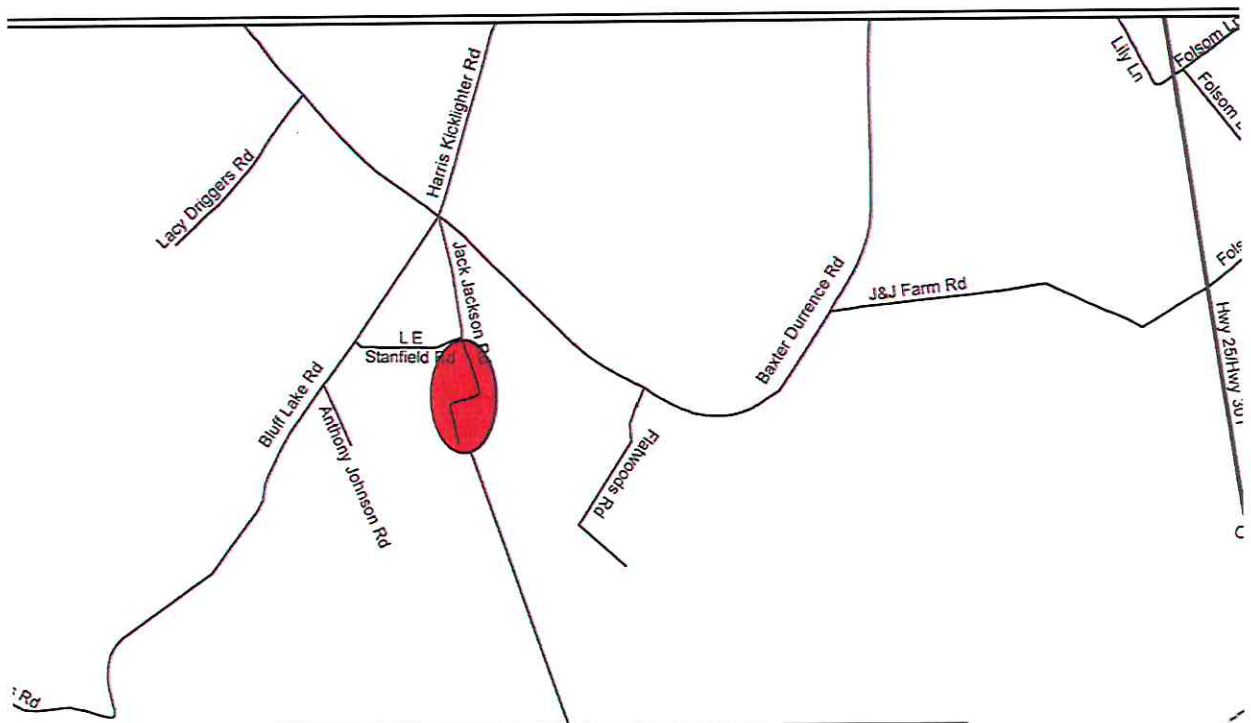

NOTICE OF PUBLICATION OF PROPOSED ABANDONMENT OF A SECTION OF COUNTY ROAD SYSTEM

PLEASE TAKE NOTICE THAT THE TATTNALL COUNTY BOARD OF COMMISSIONERS ("BOC") HAS DETERMINED THAT A SECTION OF THE COUNTY ROAD SYSTEM HAS CEASED TO BE USED BY THE PUBLIC TO THE EXTENT THAT NO SUBSTANTIAL PUBLIC PURPOSE IS SERVED BY IT OR THAT ITS REMOVAL FROM THE COUNTY ROAD SYSTEM IS OTHERWISE IN THE BEST PUBLIC INTEREST. THE ROAD IS JACK JACKSON ROAD, IN PARTICULAR THAT SECTION OF JACK JACKSON ROAD BEGINNING AT ITS INTERSECTION WITH L.E. STANFIELD ROAD AND TERMINATING WHERE JACK JACKSON ROAD ENDS WITHIN A TRACT OF LAND CONSISTING OF APPROXIMATELY 122 ACRES, WHICH IS MORE PARTICULARLY DESCRIBED BY THE TATTNALL COUNTY TAX ASSESSOR ON MAP AND PARCEL NO. 092 004. A COPY OF A SKETCH OF THE SECTION OF JACK JACKSON ROAD WHICH IS UNDER CONSIDERATION FOR ABANDONMENT IS ON FILE AT THE BOC OFFICE AT 108 W. BRAZELL STREET, REIDSVILLE, GEORGIA, 30453, FOR INSPECTION BY THE PUBLIC. THE BOC WILL HOLD A PUBLIC HEARING ABOUT THIS MATTER AT 10:00 AM ON THE 1ST DAY OF JUNE, 2023 IN THE COMMISSION MEETING ROOM ON THE 2ND FLOOR OF THE TATTNALL COUNTY COURTHOUSE, 108 W. BRAZELL STREET, REIDSVILLE, GA 30453. THE PUBLIC IS WELCOME TO ATTEND. IF SUCH SECTION OF JACK JACKSON IS ABANDONED, IT SHALL NO LONGER BE A PART OF THE COUNTY ROAD SYSTEM AND THE RIGHTS OF THE PUBLIC IN AND TO SUCH SECTION OF ROAD AS A PUBLIC ROAD SHALL CEASE.
